

REQUIREMENTS FOR HOSTING THE K OF C STATE TOURNAMENT.

TOURNAMENT DATES

OPENING WEEKEND WILL BE THE SECOND SATURDAY IN FEBRUARY AND WILL RUN CONSECUTIVE WEEKENDS THERE AFTER, USUALLY UNTIL THE MIDDLE OF MARCH. OPENING WEEKEND WILL BE DESIGNATED AS THE OFFICERS TOURNAMENT. THE OFFICERS' TOURNAMENT IS TEAM EVENT ONLY. THE OPEN DIVISION WILL START THE WEEKEND FOLLOWING THE OPENING WEEKEND. THE OPEN DIVISION WILL CONSIST OF, SINGLES, DOUBLES BOWLED ON SATURDAY AND TEAM BOWLED ON SUNDAY.

BOWLING ESTABLISHMENT WITH 32 OR MORE FULLY AUTOMATIC LANES AND AUTOMATIC SCORE KEEPING. AVAILABLE BETWEEN THE HOURS OF 9:00 A.M. AND 5:00 P.M. SATURDAY AND 10:00 A.M. 3:00 P.M. SUNDAY.

- 1. THREE (3) COMPLIMENTARY SLEEPING ROOMS FOR THE ASSOCIATION SECRETARY EACH WEEKEND OF THE TOURNAMENT.**
- 2. FULL PAGE AD IN THE SOUVENIR BOOK, ONE YEAR PRIOR TO HOSTING THE TOURNAMENT AT A COST NOT EXCEED \$200.00 FROM EACH OF THE FOLLOWING. HOST COUNCIL, HEADQUARTERS HOTEL AND BOWLING ESTABLISHMENT.**
- 3. PUBLISH AND HAVE DELIVERED BY FIRST CLASS MAIL, A SOUVENIR BOOK. TO BE SENT TO ALL TEAM CAPTAINS, EACH STATE OFFICER, AND THE BOWLING ASSOCIATION OFFICERS AND DIRECTORS. BOOK SHOULD BE MAILED BY JANUARY 10TH; THE ASSOCIATION SECRETARY WILL SUPPLY LABELS.**
- 4. THE HOST COUNCILS IS REQUIRED TO SUPPLY THE ASSOCIATION WITH A \$2,500.00 SECURITY DEPOSIT. TO PROTECT THE ASSOCIATION AGAINST LOSS OF REVENUE DO TO DEFAULT BY ONE OR MORE OF THE PARTIES CONTRACTED TO HOST THE TOURNAMENT.**
- 5. TROPHIES AND ON THE SPOT AWARDS AS SELECTED BY THE BOARD OF DIRECTORS AND/OR OFFICERS OF THE ASSOCIATION.**
- 6. ONE HEAD SCOREKEEPER AND ONE SCOREKEEPER FOR EVERY 6 LANES FOR THE PURPOSE OF RECORDING SCORES AND MAKING CORRECTIONS AS DIRECTED BY THE TOURNAMENT OFFICE.**
- 7. TWO (2) PEOPLE TO WORK IN THE TOURNAMENT OFFICE DURING THE TOURNAMENT.**
- 8. SUBS TO REPLACE ABSENT BOWLERS. A MINIMUM OF 10 FOR OPENING WEEKEND AND 5 EACH WEEKEND AFTER.**
- 9. PARTICIPATION BY AT LEAST (2) TWO TEAMS IN THE TWO PREVIOUS YEARS TOURNAMENTS, NOT INCLUDING OFFICERS TEAMS.**
- 10. COUNCIL'S MAY BID TO BE THE SOLE HOST COUNCIL OR MAY COMBINE WITH OTHER COUNCILS IN THEIR RESPECTIVE DISTRICT. IF BIDDING AS A DISTRICT, PRIOR APPROVAL BY THE DISTRICT DEPUTY REPRESENTING THE DISTRICT IS REQUIRED.**
- 11. ONLY COUNCILS IN GOOD STANDING WITH THE SUPREME AND STATE COUNCILS ARE ELIGIBLE TO BID OR HOST THE STATE TOURNAMENT.**

ALL REQUEST TO BID MUST BE APPROVED BY THE COUNCIL MEMBERSHIP AT IT'S GENERAL MEMBERSHIP MEETING AND SIGNED BY THE GRAND KNIGHT AND RECORDING SECRETARY. MAILED SIGNED COPY OF THE APPROVED MOTION TO THE ASSOCIATION SECRETARY.

ALL REQUESTS MUST BE IN THE HANDS OF THE ASSOCIATION SECRETARY BY DECEMBER 31ST.
